Making Europe Ready by 2030

7 critical capability areas identified together with the Member State:

- ▶ Air and Missile defence
- ▶ Artillery systems
- ▶ Ammunition and missiles
- ▶ Drones and counter drones systems
- ▶ Military mobility
- ▶ AI, Quantum, Cyber and Electronic warfare
- ▶ Strategic enablers and critical infrastructure protection, including strategic airlift, air-to-air refuelling, maritime domain awareness, space assets

Rebuilding European defence begins in Ukraine

- ▶ Direct EU military assistance
- ▶ Associate Ukraine to EU initiatives to develop and/or procure defence capabilities
- ▶ Integration of the Ukrainian defence industry into the European defence industry

The need for a European approach

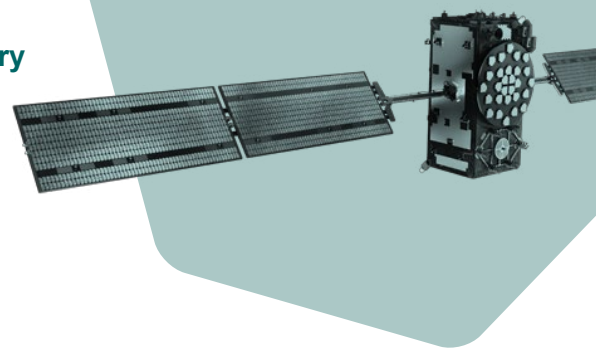
Better:
Investment in critical capability priorities, in line with existing EU and NATO processes

Together:

- ▶ Common procurement
- ▶ More interoperability
- ▶ Less fragmentation
- ▶ Economies of scale

European:

- ▶ and reduce dependencies from third countries



Establishing a strong and innovative European Defence Industry

- ▶ Aggregate demand from Member States to give predictability
- ▶ Support defence industrial ramp-up
- ▶ Place contracts to rapidly procure capabilities
- ▶ Support swift adoption of EDIP, the European Defence Industry Programme

Achieving deterrence through disruptive innovation

- ▶ Attract new defence players and disruptive technologies
- ▶ Support investment in disruptive technologies including AI and Quantum
- ▶ A European roadmap to accelerate the transformation of defence through disruptive innovation

Simplifying current legislation

- ▶ Defence Ombudsman by June 2025
- ▶ Tapping into the potential of a true EU-wide market for defence equipment
- ▶ Simplification of EU Defence public procurement
